- **7.1 Venue Search** Robyn asked for further detail on the progress of the alternative venue search as discussed at the 21 February meeting as this should be relevant to fee increases. Greig stated that this meeting had been called to discuss fee increase only.
- **7.2 Playing Fee Increase** Robyn asked why this special meeting needed to be called given that the meeting on 21 February had agreed that fees would be covered by the PBC for March and April whilst venue search continued. Greig stated that the situation had changed and that the Club could not continue to cover costs and lose money. Greig stated he had had 3 meetings with Terry Rowney, PLC/Newtown Jets manager and that they had agreed to a session fee increase to \$80 instead of \$100 until June/July.

Robyn suggested that fee increases could be covered by the PBC using the Coventry room for large days x 2 per year and self-catering as this was when the Club used to make money before moving to the PLC.

Motion: Raise the fees to \$7 per session per player from 1 April 2019 whilst we continue to play at the Parkes Leagues Club and review again if we move venues.
